**INTRODUCTION:**

Recreational Marijuana is now legal in Michigan. Right now, an individual is allowed to grow up to 12 marijuana plants indoors for personal use, can carry 2.5 oz. of recreational marijuana on their person, (and possess up to 10 oz at home if the marijuana in excess of 2.5 oz is "stored in a container or area equipped with locks or other functioning security devices that restrict access to the contents of the container or area." and can use marijuana on private property, indoors. This is the list of marijuana establishments that MAY be licensed in Michigan, under current emergency regulations, if the local governing bodies allow such licenses in their jurisdiction: (Please note: in Michigan, it is spelled "marihuana")
